

iGaming Business Directory Artwork Submission Guidelines and Specifications

Ad and Logo Artwork Required Format

- **High resolution PDF files** are preferred with all fonts embedded. Also will accept **.eps, .ai, .jpg, .psd, or .tif** formats
- CMYK (four color process)
- 300dpi (dots per inch) resolution
- Supply any linked images or photos
- Fonts changed to outlines for vector based files (.eps, .ai)
- NO internal image compression (lzw, jpg)
- NO Mac files that cannot be open on PC
- NO printer's marks (i.e. crop marks)
- NO header or footer information
- NO graphics or text that are not part of the ad

How to Submit Ads and Logos

Compress all files and create a folder based on the advertiser's company name and label file as: "GBD-Your CompanyName-ad" (for ads) or "GBD-Your CompanyName -logo" (for logos)
 Note: GBD stands for Gaming Business Directory

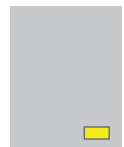
